North Point School is proud to offer a need-based Financial Assistance Program. We understand that every family's financial circumstances are different, especially when there are multiple school-aged children. We welcome all boys who will benefit from our incredible program and will work with every family who needs that extra assistance to make it happen.

In order to be considered for financial assistance, all families must complete an assistance application form. All completed forms must be submitted to North Point School's Business Manager in confidence. Our Assistance Assessment Committee (AAC) will review your application within 5-10 business days of submission. This small committee consists of the Head of School, Business Manager and Board Chairperson. All information submitted is protected under absolute confidentiality. Immediately after assessment, the results will be communicated to the families by phone and a follow-up letter. Due to the subject nature, electronic communication will be avoided.

Basic Guidelines & Instructions

All assistance is based on need and is determined by the Assistance Assessment Committee (AAC) at North Point School.

Financial Assistance funds are limited and all successful applicants will be required to pay a minimum amount of tuition fees as determined by the AAC. Not all applicants will automatically be eligible for financial aid.

A new application must be submitted for each school year. If applying for more than one child in your family, please list the students' names on the North Point Student Information section. Only one application needs to be completed per family.

All applicants must complete the application in full and will be expected to provide all necessary documentation as requested. A Notice of Assessment(s) from Canada Revenue Agency will be required. The AAC reserves the right to request additional information from any applicant. Please note that all information will remain strictly confidential.

Deadlines

All applications must be submitted by **August 15, 2019**.

All applicants will be notified in writing and by phone of the decision of the AAC.
